



Key-Take Away from CDS 2024



Cybercrime is projected to cost the world **\$9.5 trillion USD in 2024**, making it the thirdlargest economy after the U.S. and China if measured as a country. This figure is expected to grow by 15% annually, reaching **\$10.5 trillion USD by 2025**, driven by data destruction, theft, fraud, business disruption, and regulatory costs. The rapid adoption of mobile, cloud, IoT, and remote tools has fundamentally reshaped how technology is utilized, amplifying vulnerabilities to cybercrime.

Two major challenges facing organizations today are **data privacy** and **synthetic fraud**, which leverages fake identities for financial crimes. As businesses increasingly rely on data, safeguarding it from unauthorized access has become critical. In 2024, significant investments in data privacy compliance are anticipated as organizations tackle synthetic fraud's evolution, emphasizing prevention and detection to mitigate financial risks effectively.
